Annual Meeting and Presentation of "Spirits of Ionia" Characters

Minutes of the Annual Meeting

The meeting was called to order by president Kathleen Cook at 7:05 p.m. on Wednesday, October 5th, 2016. Linda Ciangi moved to forego the reading of the role call, past annual meeting minutes, and September general meeting minutes. The motion was supported by Mike Gallagher and passed. The president noted that public notice of the meeting had been published according to the ICHS Bylaws, then announced the three candidates for the openings on the Board of Directors: Dave White, Goose Elliott, and Ally Cook (incumbent). Mike Gallagher moved to cast a unanimous vote for the three candidates due to their being only three openings on the Board. The motion was supported by Bryan Kimble, and passed. Linda Ciangi then moved to adjourn the annual meeting, which was supported by Mike Gallagher and passed. The meeting was adjourned by president Cook, asking that the new Board and officers please assemble after the general meeting for a brief Board Meeting. The annual meeting was adjourned at 7:10 p.m.

Minutes of the October 5th General Meeting

The meeting was opened by president Kathleen Cook with a report on the recent Fall Festival and Cemetery Tour. Both events were considered successful, although Fall Fest was sparsely attended due to a combination of threatening rain and competing events. In contrast, the weather for the "Spirits of Ionia's Past" was near perfect, with a very good attendance. Between the two over \$650 was brought in for the ICHS general fund.

The Michigan-1 Credit Union has contacted the ICHS about their employees volunteering in the community. They would like to help out at the Blanchard

House, and Kathleen will follow up to see what can be arranged.

A bus tour group is visiting us on the 13th. It's a large group with very little time to spend, so volunteers will be appreciated.

Once again, the McCords (David and Annette) will host Trick-or-Treat at the Blanchard House this Halloween - rain or shine. If anyone would like to contribute candies, please do. (Laws dictate that only store-bought pre-wrapped candy can be handed out.)

Plans are in place for the October 18th library program at the Blanchard House (see story on page one for details). The Tri-River Museum Group will be returning to the Blanchard House for their November meeting on the 18th as well (10:00 a.m.). The November general meeting will be a program about "The Lost Car Companies of Detroit," also at the Blanchard House.

Further along on the calendar, the Blanchard House Bazaar will be held on November 27, and the Mrs. Claus Bazaar at the Middle School on December 4th.

Linda Ciangi reported that the City of Ionia would install a sign to acknowledge our “adoption” of the Cornell Alley. The City Council is also in support of the proposal to adorn some of the large brick walls of buildings in the business district with history-centric murals. Several owners have expressed interest, and the city will recruit local artists to do the work. In addition, plans for the Governor Green / Ypsi-Reed monument is progressing as well, hoping to identify grants to help fund the project. Portland sculptor Derek Rainey will be contacted to bid on the statue of the former Governor.

The Treasurer’s report was brief and optimistic due to the recent influx of funds from various events, as well as membership fees and donations. The full report is available on request.

Kathleen closed the meeting with a thank-you to Gordon Wright and Patty Simpson-Gokee for their service to the Historical Society as members of the Board of Directors, and expressed the hope that they are always welcomed to be involved in the future in whatever capacity they’d like.

The general meeting was adjourned at 7:35.

Minutes of the Board Meeting of October 5th

The ICHS Board of Directors met at 7:54 p.m. Present were Directors Kathleen Cook, Linda Ciangi, Ally Cook, Dave White and Goose Elliot, plus Secretary David McCord and Treasurer Annette McCord. Ally Cook moved that the election of officers be postponed until the regular Board Meeting on the 19th, which was supported by Goose Elliott and passed. Information had been received via the website regarding possible advertising for the ICHS which requires further research. The Tri-River Group bus trip is coming soon (will be attended by Goose Elliot and David & Annette McCord), which brought up the discussion of the ICHS arranging a bus trip to Greenfield Village at some point. Ally Cook is looking into the possibility. Linda Ciangi reported that Linda Curtis of the DDA had an inquiry from a photographer who would like to take pictures at the Upstairs-Downtown Tour in 2017, and also that she is trying to arrange a committee meeting for next year’s Oz Festival. With that, Dave White moved that the meeting be adjourned. The motion was supported by Ally Cook and passed. The meeting was adjourned at 8:10 p.m.

Minutes - Oct 19 Board Meeting

The Board meeting of Oct. 19 was called to order by president Kathleen Cook at approx. 7:10 p.m. Also present were Directors Ally Cook, Linda Ciangi, Goose Elliott, and Dave White, plus former director Gordon Wright, rental chair Barb Ehlert, Treasurer Annette McCord, Secretary David McCord, and Accessions Committee member Shawna Hoekstra. (We also had a brief visit from Patty Simpson-Gokee!) Gordon turned in his key (#13) to the Board, but after he left the meeting it was noted that he was listed as the emergency phone number with the alarm company. In that role, he would need the key. Kathleen said she would talk to him to see if he was still willing to serve in that capacity.

The agenda opened with a brief Treasurer’s report: there is approximately \$16,000 in the checking account. Funds were received at this meeting for the sale of souvenirs and some tour donations. More memberships are in but not yet counted. (Later in the meeting a question arose regarding a credit at Pro Print which will be investigated anon.)

The toilet at the Blanchard House had a problem which was fixed by Wilson’s - charges yet to be billed.

The recent tour group of 50 persons was fun, but the Board agreed in discussion that we should make it clear that more time is needed to give people a reasonable tour, especially with that large a crowd.

Shawna Hoekstra and Mary Kimble have met with Barb Hogan, and the three of them will constitute the formal Accessions Committee moving forward. They are in the process of developing an accessions plan, catalog system, and inventory for the ICHS collections. More will be reported as plans unfold.

The old Ionia County Jail is being torn down to make room for a new office building. There are some artifacts which may be of historical interest, and Kathleen has gathered some of it in the Carriage House. There is more coming (the Accessions Committee’s first big challenge.) A trailer will be needed to get the next wave of stuff, to be taken to our storage space at the back of S&K Printing. Dave White may be able to help with that, depending on the timing.

The Chamber of Commerce has informed the ICHS that they will not be able to participate in the Chili Dog Challenge. Technically, we should not have been participating in past years either, at least on our own behalf. The event is for the benefit of Big Brother / Big



Sisters, and we could participate if we gave proceeds over to them. The Board chose not to take part in the event this year.

Dan Balice has rented the Blanchard House for a retirement party on December 16th. He has asked the Board to approve the presence of beer and wine for the gathering, and the Board accented to that request.

Kathleen and Ally will attend the next Chamber Breakfast to represent the ICHS. A discussion ensued about official representation at meetings of the City Council and County Board. The Board concluded that “official representation” was a difficult role, and that Board members who attend such meetings are only there to collect and report information. Said members should also make it clear that IF they comment, it is (for the record) only on their own behalf and not that of the ICHS. It was suggested that a “boilerplate” for a general resolution be written that could be presented if and when topics of historical interest come up. Something that could convey the feelings and position of the ICHS on a case-by-case basis, for the record. Specific action was not taken by the Board at this time.

The Tri-River Group meets at the Blanchard House on Tuesday, November 15th, at 10:00 a.m. Joan McCord has offered to furnish refreshments for the meeting.

The revised “Docents Guide” for the Blanchard House is available for any folks interested in helping with tours. In that document, it notes the use of the upstairs parlor (the “tea room”) as a work area. The Board agrees that there is no choice, but that it needs to be kept in good order and at least the door open to tours. The work area is to be roped off. David McCord can loan two large work tables and stands for a “velvet rope” for the area. This will also serve as the first stop for the Accessions Committee when new donations come in (unless impractical).

The house will soon be getting ready for the holiday decorations. Any interested parties can volunteer to help with that by contacting a Board member. It was suggested that the Michigan-1 Credit Union volunteers may be able to help with that. In addition, a 10-foot pop-up display has been donated by M-1 C.U. for our use.

Goose said that he’d heard some comments about the Oct 5th meeting running way too late. This was an exception, being a reading of the Cemetery Tour scripts and not a normal presentation. The Board discussed the issue, noting that the program does sometimes run late, and the bit of business conducted before the scheduled

program can sometimes run long as well. The Board decided to reorganize the meeting and review business after the program to see if that worked better for those who need to leave earlier. They will also make it clear to presenters that they should try to limit their presentation to an hour.

Linda Ciangi passed around a letter of support she’d written for Joshua Pardon, the producer of the documentary on “The Factory” in Ionia. The film is being shown now on over 60 PBS stations around the country. In appreciation, she asked the Board if they would sign the letter to support Mr. Pardon seeking a promotion at Ferris State U. The Board agreed to do so, and Linda will formalize the letter accordingly.

Larry Listerman, Ionia Township Supervisor, suggested that the ICHS publish a public thank-you to the Township for the use of the Highland Park Cemetery for our tours. The Board agreed that it would be a good diplomatic move, but would not approve funds for an ad without knowing the cost first. Linda would investigate and report back to the Board.

Laura Listerman has informed Linda C. that the stained-glass windows in the Friend of the Court building may be made available to the ICHS in the event that the building is torn down.

Tim Marshall, local horse owner, has acquired a new carriage. Linda asked if the Board would like to reserve the carriage for next year’s Free Fair Parade (if it’s available). The Board said she should check on it, and keep it in mind for other events.

The Methodist Church is hosting a bazaar on November 12 and has invited the ICHS to take part if we’d like to. The opportunity will be brought to the general membership to see if we can staff a table to sell souvenirs. More information to come.

The final item on the Board’s agenda was the election of officers for the coming year. (For the record, Ally C. and Dave W. declined any nomination to an office before the nominations were presented.) Kathleen nominated David McCord to continue as Secretary and Annette McCord to continue as Treasurer. Linda C. supported the nomination, and the Board voted “yea” unanimously. Linda also moved that the President (Kathleen C) and Vice President (Linda C) be retained as well. Dave White supported that motion, and the Board voted again unanimously to do so.

Dave W. moved to adjourn the meeting, which was supported by Ally and passed. The meeting was adjourned at 8:45 p.m.
