Happy New Year!

"Happy New Year!" That greeting will be said and heard for at least the first couple of weeks as a new year gets under way. But the day celebrated as New Year's Day in modern America was not always January 1.

The celebration of the new year is the oldest of all holidays. It was first observed in ancient Babylon about 4000 years ago. In the years around 2000 BC, the Babylonian New Year began with the first New Moon (actually the first visible crescent) after the Vernal Equinox (first day of spring).

The beginning of spring is a logical time to start a new year. After all, it is the season of rebirth, of planting new crops, and of blossoming. January 1, on the other hand, has no astronomical nor agricultural significance. It is purely arbitrary.

The Romans continued to observe the new year in late March, but their calendar was continually tampered with by various emperors so that the calendar soon became out of synchronization with the sun.

In order to set the calendar right, the Roman senate, in 153 BC, declared January 1 to be the beginning of the new year. But tampering continued until Julius Caesar, in 46 BC, established what has come to be known as the Julian Calendar. It again established January 1 as the new year. But

in order to synchronize the calendar with the sun, Caesar had to let the previous year drag on for 445 days.

Although in the first centuries AD the Romans continued celebrating the new year, the early Catholic Church condemned the festivities as paganism. But as Christianity became more widespread, the early church began having its own religious observances concurrently with many of the pagan celebrations, and New Year's Day was no different. During the Middle Ages, the Church remained opposed to celebrating New Years. January 1 has been celebrated as a holiday by Western nations for only about the past 400 years.

Tina Connor-Wellman at the Chamber asked if the ICHS would like to have the Blanchard House open the afternoon of the Christmas Parade for next year, to add to the community's festivities (and advertising) for the day. It was also suggested that we invite the Garden Club to the annual pot-luck. as well as the various businesses and service-providers that help out during the year (lawn-care, window-washing,

There are several rentals on the calendar for the Blanchard House in upcoming weeks, and all arrangements are in order.

150 YEARS AGO — DECEMBER 1860

The cover of Harper's for December 20 depicted a variety of happy scenes for the holidays, but the news on its inside pages was grave. There was a new independent republic on the North American continent! The Republic of South Carolina had seceded from the Union, and would soon be followed by several other states. Dissatisfied with the sectionalist trends in the politics and legislation of the United States, and the weak response of President Buchanon to the situation, the threats of the South's leadership became all to real. The dubious election of Abraham Lincoln, whose outspoken animosity towards the South's right to dissolve their allegiance to the Union, inspired the Southern Convention to act. South Carolina was the first, and declared itself a "sovereign state" by vote of the legislature on December 20, 1860. The Confederate



States of America would not be officially formed until March, 1861. So, for nearly 3 months, the "Palmetto Flag" represented a "free and independent state."

needed so the restaurant can prepare a place for ICHS members. Please make your plans in time for the January meeting if possible.) The monthly business meeting will be Feb. 16th. The March program will be presented on the 2nd at the Presbyterian Church in celebration of their 150th anniversary.

In addition to regular monthly meetings thereafter...

March 11 will be the annual Community Expo at the High School where we will again have a booth, and April 2nd will bring another Appraisal Road Show at the Commission on Aging. April 30 and May 1 will be the annual Tri-River Museums Weekend ("Spring Into The Past"). Being May Day, the Board discussed hosting some special activities on the lawn, including outdoor games and possibly a May Pole, period music and costumes, and a possible scavenger hunt (a popular Victorian pastime).

A new chairperson for Summer Sundays is being sought. The Board noted that it will be difficult to follow the great job done by Joan McCord this year, but the impact of a successful Summer Sunday program has been proven now, and the opportunities should not be missed. Being the 150th anniversary of the Civil War, displays on that topic are an obvious choice this year. But also for summertime, a "Teddy Bear Picnic," or an "American Girls Picnic" were suggested. (This being less formal than a "Tea"). It was noted that later in the summer there would be fewer mosquitoes to spoil the picnic perhaps an August time frame.

There was a call from a person asking about the history of the property

where the Ford dealership was. It was a real estate broker, not so much a historical interest. This prompted a discussion about such inquiries, and the Board agreed that sending these folks to the Court House and City Hall is the normal response. Owners would be another matter, such as a recent inquiry about the former site of Rod's Bar, now called "Barb's Bargains," who is seeking historic information about the site.

Carol Gallagher shared the plans put together with suggestions from the Garden Club and Kathleen Larock for the Gardens at the House, with a projected budget of \$150 to \$175. After some review & discussion, Carol G. moved that the plan be adopted for next spring. The motion was supported by Patty S. and passed.

The subject of ICHS responsibilities for keeping the snow off our sidewalks was discussed. While arrangements with the Sheriff's Dept for inmates to do the work is a great arrangement, it is not entirely reliable. On those days when inmates are not available, the ICHS is still in need of the service, and subject to a fine if the walks are not cleared. The Board will look into services for hire, and check with our neighbors at McKaig and Balice about their arrangements, as well as others.

Kris H. also noted that the Carriage House is in need of some professional cleaning. The roof project caused quite a mess, and before the building can be used for public displays or demonstrations (as well as storage), this should be done. It was noted that some money was left over from the roof project that might pay for this service. Research continues so that this can be done in the early spring.

Carol G. suggested that we put together a flier to hand out that explains


