# "Markers In The Mitten"



Our special guests for the November 3 meeting were Joe Finkbiner and his friend Tamara, with their presentation called "Markers in the Mitten." To start with, here's a little background information:

In 1941, the Michigan legislature authorized the Michigan Historical Commission to begin an historical marking program. This program had to be abandoned when the United States entered World War II, but in 1953, Willis F. Dunbar led an investigation of Michigan historic sites (Dunbar was a professor at Western Michigan College – now Western Michigan University – and a Michigan Historical Commission member.). Backed by Dunbar's research, the Commission again asked the legislature for authority to mark historic sites.

The marking program officially began in 1955. Fifty-five years ago – on October 22, to be precise – the very first Michigan

historical marker was dedicated. It was placed at Michigan State University, during that institution's centennial year.

From then until the present, over 1,600 state historical markers have been erected, of which 1,500 are still in place. Joe & Tamara took it upon themselves to visit all of them over the past 14 months. Traveling the width and breadth of Michigan, from tiny roadside sites to big city institutions, photographing, verifying, and documenting them all.

Joe had been interested in the Markers when he was young, and his interest was renewed recently. Some of the markers were very hard to find, some were at the wrong address, and some

hard to get to once they were found. Joe has based much of his research on two sources: Laura Rose Ashley's "Travel Through Time" (a guidebook written in 2005) and a website at www.michmarkers.com. He hopes to publish the journal of their journey, as well as their findings, in 2011. The book will include detailed stories about 150 significant markers, as well as corrections and helpful hints for interested readers.

#### MINUTES of the November 17, 2010 Business Meeting

The Board of Directors met at the Blanchard House at 7:00 p.m. on Wednesday, November 16, 2010. Present were directors Carol Gallagher, Patty Simpson-Gokee, and Linda Ciangi, plus Secretary David McCord, Treasurer Hank Knoop, and committeeperson Doni Knoop.

Linda and Doni reported (in chairperson Stephanie VanderMolens absence) on the recent Mind-Body-Soul Expo that was held at the house on November 13 was well received and attended, and the organizers are interested in a repeat of the event - possibly twice in 2011.

President Ciangi also reported that the Michigan-1 / Chamber After Hours event was a success as well (but we didn't win the \$300 door prize). Thanks to everyone who helped with the display and presentation. (A \$30 invoice was submitted to the Treasurer for the logo banner.)

The Ionia Community Foundation met at the Blanchard House recently, with 64 people in attendance, and the meeting was a great success. The Tri-River Museums Group met at the house recently, served with a catered luncheon which was well received with over 40 people at the meeting.

Kris Haskins' report on the groundskeeping progress was tabled until he can attend.

Sorting and boxing of collections in the Blanchard House continues, with progress being made every week. Access for the public in some of these work areas was discussed, noting that some areas should be cleaned up for visitors during the Christmas open houses. The Thursday work sessions have recently been starting at 1:00 p.m. to give volunteers more time. Linda C. asked if another Board member could be at the house on the 17th for a couple of hours while Linda attended to other obligations. Carol G. and Doni K. will take care of it.

Upcoming events require chairpersons, and the following were established by the Board: Community Expo (March 2011): Patty S. — June Yard Sale: Doni K. and Barb E. — Antique Village at the Free Fair: Knoops with Carol G. cochair - Free Fair Parade Float: Linda C. — It's hoped that Joan McCord will continue to chair Antique Appraisal Roadshow, Upstairs Downtown, and Summer Sunday programs. Other potential events were noted, including Cemetery Tours, Lawn Parties, and something with the Community Theatre and/or Library. Carol suggested promoting a possible Mother-Daughter event as well.

Doni reported that she had seen the doll house being offered by Weavers for a door prize, and wasn't sure about the appropriateness of it as a raffle prize - especially noting that Weavers have apparently raised the price.

Historical Markers program was discontinud, and is now being managed by a third party. Its future is still unsure at this point.

Joe noted that several Michigan markers are actually outside the state, erected by Michigan organizations and related to Michigan history in some way. He said that his favorite sites were the Lang-Mason House in Genesee County (a restored private home), and the Honolulu House in Marshall (a very unique architectural curiosity.) He also noted that there are over 400 Historical Markers in Wayne County, and only 120 in the Upper Peninsula. New Markers are being applied for through the aforementioned third party, so the list continues to grow.

Our thanks to Joe and Tamara for an excellent presentation, and for all their efforts in documenting this wonderful example of how our state's history is shared.

The Buckaroo Ball will be February 2, and last year's donation of a "free rental" of the Blanchard House was very successful. Carol moved that we offer the same this year, which was supported by Patty and passed, with the stipulation what we add an 18-month expiration date to the certificate.

Linda shared a collection of fliers / posters from the Wyandott Museum for their year's activities, and the Board wants to consider this as a model for our own promotions. The samples will be shared with Stephanie V.

Linda C. also shared a pamphlet from the MMI regarding the availability

of "interns" for certain projects whose time is paid for by that agency.

The ICHS was contacted by the Smith family (relations of Judge Geer Smith) who have a bookshelf and settee they would like to donate, if the ICHS is interested. Also, Ian Lockwood (grandson of Walter Lcokwood, who lived in the Blanchard House), has a piano that was once in the house. Contact information for both of these has been given to David M. as representative of the Accessions Committee to follow up.

Linda also continues to work with Pastor Kate from the Presbyterian Church on thier anniversary plans.

Linda reported her plans to host another Concert Fundraiser in summer 2011 at the Ionia Theatre. She will be the "producer" of the show, and will assume the risk. She is offering the proceeds to the ICHS. Patty S. moved that the ICHS endorse the event, which was supported by Carol G. and passed by the board.

Carol G. asked about the recommendations of the Garden Club that had been decided upon this past summer. No one seems to know what the final decision was, and Kathleen Larock will be contacted for the information.

Hank K. reported that letters are being sent to members whose dues are overdue, as well as letters to "business buddies" and other area businesses to solicit their support.

Permission is being sought to serve a punch containing liquor at the Blanchard House for a private party on December 27. Patty moved to allow this, supported by Carol and passed by the Board.



#### A LITTLE TURKEY DAY HISTORY

We owe the modern concept of Thanksgiving to a woman named Sarah Josepha Hale. Hale, editor of Godey's Lady's Book and author of the famous "Mary Had a Little Lamb" nursery rhyme, spent 40 years advocating for a national, annual Thanksgiving holiday. In the years leading up to the Civil War, she saw the holiday as a way to infuse hope and belief in the nation and the constitution. So, when the United States was torn in half during the Civil War and Lincoln was searching for a way to bring the nation together, he discussed the matter with Hale.

On October 3, 1863, Lincoln issued a Thanksgiving Proclamation that declared the last Thursday in November (based on Washington's date) to be a day of "thanksgiving and praise." For the first time, Thanksgiving became a national, annual holiday with a specific date.

For 75 years after Lincoln issued his Thanksgiving Proclamation, succeeding presidents honored the tradition and annually issued their own Thanksgiving Proclamation, declaring the last Thursday in November as the day of Thanksgiving. However, in 1939, President Franklin D. Roosevelt did not. In 1939, the last Thursday of November was going to be November 30. Retailers complained to FDR that this only left 24 shopping days to Christmas and begged him to push Thanksgiving just one week earlier. It was determined that most people do their Christmas shopping after Thanksgiving and retailers hoped that with an extra week of shopping, people would buy more.

So when FDR announced his Thanksgiving Proclamation in 1939, he declared the date of Thanksgiving to be Thursday, November 23, the second-to-last Thursday of the month.

The new date for Thanksgiving caused a lot of confusion. Calendars were now incorrect. Schools who had planned vacations and tests now had to reschedule. Thanksgiving had been a big day for football games, as it is today, so the game schedule had to be examined.

Political opponents of FDR and many others questioned the president's right to change the holiday and stressed the breaking of precedent and disregard for tradition. Many believed that changing a cherished holiday just to appease businesses was not a sufficient reason for change. Atlantic City's mayor derogatorily called November 23 as "Franksgiving."
