From the Editor - This issue is heavy on Meeting Minutes and not much on history and entertainment. I apologize for that imbalance, and will attempt to remedy the situation in future issues. - D.M.

Minutes of the Board Meeting of Sept 20, 2018:

Present were Linda Ciangi, Barb Ehlert, Kathleen Cook, David McCord, Ally Cook, Margot Cook. The meeting was called to order at 4:15 p.m.

The primary purpose for the meeting was to discuss progress on the "Rockin' the Block" beer tent fund-raiser scheduled for October 13th in the 400 block of West Main St.

Chairperson Ally Cook shared her progress in working with city officials, bar owners, music providers, and so on. She brought to the table permits, which cost \$25 to file, for serving the alcoholic beverages. It was moved by Ally and supported by Linda to spend the \$25 and complete the forms on behalf of the ICHS. The motion passed with a phone vote from Director Stacy Tchorzynski. Most of the form was completed at this meeting, with a few items remaining to be completed soon after. A "bond" is required for the permit, and Ally was directed by the president to check with Jerry Gregory for that.

There was discussion about a large tent rental, wrist bands, beverage arrangements, entertainment, possible foods to be offered, and bringing in a root beer vendor for the non-alcoholic attendees. The event would be free and, except for the beer tent itself, would be open to any age group.

David McCord presented draft copies of flier/posters for the event, and (pending final edits from Ally) would submit the file to S&K Printing for production.

On another subject, David M. also submitted receipts for newsletter

postage, and several membership checks were passed along to Treasurer Kathleen C. Also, to pass along to the Accessions Committee, were two land grant certificates (from the Belding Historical Society) and an Ionia Water Works postcard (from the Portland Historical Society) to add to the collection.

The meeting was adjourned at 5:00 p.m.

ICHS Board Meeting, 092618

The meeting was called to order by President Ciangi at 7:00 in the Blanchard House. Also present were Barb Ehlert, Stacy Tchorzynski, David White, David McCord, Ally Cook, Goose Elliott, and Shawna Hoekstra.

President Linda opened with comments regarding commemoration of passed members Gordon Wright and Dave Odette, seeking some kind of memorial for their contributions. The Board expressed support for the idea, but nothing specific was decided at this meeting.

One correction was noted for the Secretary's Report as published in the September Chronicle: The pie sale should have been mentioned in relation to the November Church Bazaar, not the Mrs. Claus Sale. Goose moved to accept the report, supported by Dave W. and passed.

Treasurer Kathleen Cook was not present to render a report, but some dues payments and money from recent visits to the Blanchard House & Museum were turned over to Ally Cook to pass along to Kathleen.

Accessions Committee members were not present, but it was noted that there is now a plastic bin in the back entry area for new acquisitions (that will fit into it). A clipboard with Accessions Forms has yet to be provided for it.

Dave White reported on several items as Grounds and Maintenance, as the subjects were addressed according to the president's agenda.

An estimate of \$400 was received from Bert's Glass to have the window panes in the south wall of the Carriage House replaced with acrylic. Goose moved to have this done using funds from the Hank Knoop Memorial. Ally supported the motion, and it passed. Dave W. also asked the board to check an opening further up in the wall which may need attention.

We're still awaiting an estimate to refurbish the electrical system in the Carriage House.

The new kitchen door is in place and primed but needs painting. The Cooks will check on getting the paint. David M. noted that he thought the cost of the paint for the door had been previously approved (along with paint for the servants stair-steps). (Record of this could not be found, so a Board vote is still needed to pay for the paint.— D.M.) In case this was not true, the Board approved the expense anew.

The replacement plans for the steps at the back porch, and the addition of a wrought-iron railing on the porch, were discussed. The Board was in favor of the plan described by Dave W. and asked him to carry on with plans to get the work done, hopefully yet this year.

Under "Old Business" — Linda offered a report on the Yard Sale beginning with thank-yous to those who helped with the event. Nearly everyone purchased something from the tables. The total earned has not yet been tallied, but it was certainly a success. Items not sold were forwarded to Goodwill or the "Safe Haven" sale at the Animal Shelter.

The Carriage House clean-up continues, and another round of cleaning will be set up for a day in November (details to be announced). (This day may also included painting the new back door off the kitchen, noted above.)

Additional items have been moved to storage at the Sentinel-Standard facility. A detailed list will be forwarded to the Accessions Committee. Linda asked for Board approval to hire Stan Preston and his crew for one final load of items to be hauled from the Carriage House to storage at a cost of \$150. Goose made the motion, supported by Stacy, and passed.

Plans were reviewed once again for the Beer Tent event "Rockin' the Block." There was no change to the info shared at the Sept. 20th Board meeting, except that Jim Killion has lined up three bands for the entertainment. The re-edited poster/fliers for the event would now be submitted to S&K Printing for production - Ally would follow up with S&K.

The upcoming "Spirits of Ionia" Cemetery Tour was on the agenda. Kathleen C. was not present to give a report, but information was shared

by those who would be participating in the event. Aside from sparse publicity and late research, it appears that plans are on track for Sunday afternoon.

It was also noted that the Library is planning to host another Dinner Theater event at the Blanchard House on November 3rd, and Stacy T. will be our host at that event.

Under "New Business" — A visitor to the house mentioned that a "grab bar" for safety might be added to the restroom. Goose moved to add that to the maintenance list, which was supported by Stacy and passed.

Barb E. reviewed recent changes she's made as to how and where dinner ware and kitchen supplies are being stored. Glassware in particular had been stored on high shelves, and is now lower where it can be reached more easily (and safely). She also suggested that a small overhead kitchen cabinet might be mounted to the pantry wall behind the door to store paper products and cleaning supplies. Presently, these are either on hard-to-reach shelves or on an open wire rack. The Board supported the idea, voting to "keep an eye out" for a good deal on a cabinet, either at Goodwill, Enrich, or the ReStore.

Barb also noted that the vacuum sweeper is not operating as it should, and asked the Board's permission to take it to the Sweeper Shop for repairs. Ally moved to have this done, supported by Dave W. and passed.

The Mrs. Claus Bazaar will be on December 1st this year. A chairperson is needed to arrange the sales event for us, and volunteers needed

to set up, staff, and take down the ICHS booth. The general membership will be asked to help at the next meeting.

Linda and Barb, who handle the holiday decorations at the Blanchard House, asked the Board if we couldn't purchase a new 12-foot artificial tree for the front parlor. The previous trees are showing their age. The consensus was to asked the membership for a donation, as well as checking with Char Sherman (who has many such items) if she might make us a deal. Linda C. will check with Char. In addition, the request is out for help to clean up the house before the holiday open-houses.

Finally, some discussion was had regarding programs for next year, to make an attempt to fill the schedule earlier this time. David M. mentioned that Al Bryant has a couple of programs we have not yet seen, and that Valerie Marvin from the State Historical Society would like to address our group as well. David also said he would check with other museums in the Tri-River Group for possible programs. Other suggestions were to visit Central Dispatch in February, WION in March, and Stacy said she may have connections to visit the old "Nunnery" on High Street sometime. Someone also mentioned members of the local civic organization's history. Again, the general membership will be approached to get suggestions.


As a post-script, David M. mentioned that he had attended a meeting hosted by the Kutche Center for Local History at GVSU. The meeting included representatives from communities all along the Grand River, and GVSU has a grant to put together a display of how these communities have been affected by the River, or their relationship to the River. David will continue to keep in touch with this effort. He also reported briefly on recent Tri-River meetings, upcoming Tri-River events, and an upcoming workshop called "History Skills Bootcamp" to be held at Lansing Community College by the Historical Society of Michigan.

The meeting was adjourned at 8:40 p.m.

At 7:00 p.m. while awaiting the arrival of some key members, president Linda Ciangi related some late-breaking news about current projects - specifically the Carriage House. The building is nearly cleaned out and in the process of reorganization. Bert Dickinson will be in this week to replace the cloudy plexiglass in the south windows with acrylic panes, and hopefully be able to fix the broken panes in the gable windows at the same time. Chris Bredice will be in before the end of the month to rewire the electrical service in the building to bring it up to code. The electrical will not be too obvious, so we can preserve the historic ambience of the building.

2018 Annual Meeting -

At 7:13, the Annual Meeting was brought to order by Linda C. Sharing the requirements of the meeting as put down in the ByLaws, she entertained a motion to forego the initial steps and get directly to the Board Elections. The motion was made by Mary Kimble and supported by Phil Kahl, and passed by the assembled members.

Secretary David McCord passed out membership forms to those paying their last-minute dues, and passed the forms and moneys on to Kathleen Cook, Treasurer. Then ballots were distributed, votes cast, and ballots collected. The Secretary and Treasurer then retired to the office to tally the votes (including those mailed in ahead of the meeting) and verify the paid members on the list. The candidates for two Board positions were Phil Kahl, Katelyn Mooney, and Barb Ehlert. David M. then announced to the members that, of 27 votes cast, the new Directors on the Board would be Katelyn and Barb for a regular two-year term. Phil was thanked for his candidacy and continued support, and the out-going Directors, Goose Elliott and Ally Cook, thanked for their service as well. The annual meeting was then immediately adjourned at 7:45.

2018 Membership Meeting -

The regular monthly meeting was then brought to order by President Ciangi, with several reports delivered to the members.

Kathleen reported that the year-end Treasurer's Report was being compiled and should be available to all by the November meeting. She also reported that recent events have brought in some funds: Fall Festival, \$15; Yard Sale, \$1,250; Cemetery Tour, \$275. Sarah Hamilton has donated \$3,000 to the Society as well. Kathleen has yet to total all the membership dues that have come it, and once that's done will coordinate with David M. to put together an accurate membership list.

Kathleen reported that the Cemetery Tour on Sept 27 went well despite the rainy weather. We've made more money in the past, of course, but those who attended shared many positive comments. Linda C. noted that Gary Ferguson at the Ionia Theatre said he would show the documentary file on the Salem Train Wreck some Sunday afternoon. Kathleen & Goose were discussing a scheduled bus trip to retrace the route of the train to Detroit, and possible visits to the same destinations (much changed and some no longer there).

Ally Cook then reported on the progress for her "Rockin' the Block" beer tent event coming on October 13th. She listed the permits and approvals she has arranged for the event. The beer tent will be in the parking lot next to the Armory, the entertainment set up on the street. She is seeking some snow fence to surround the "alcohol limits" for the event, and needs volunteers to staff the tent and help with wet-up and take-down. Linda and Ally had the opportunity to take a tour of the Hanlon Prison (a.k.a. "MTU), focused on the schools and training facilities for the inmates. They saw many examples of skilled and talented work by the inmates. One of Linda's primary interests was the autobody shop, where in decades past many custom autos were produced and showcased at the Ionia Free Fair. One of the others on the tour had been a former instructor in the shop, and related stories of past projects. A highlight was a Shelby Cobra engine still on hand from the late 1960s.

Kathleen also reported that the Tim Lockwood family had visited the Blanchard House last week. The Lockwoods lived in the house for over 40 years, and shared memories as they walked through the house.

Upcoming events were discussed, including the need for volunteers. The Blanchard House needs to be cleaned up and decorated for the holidays. This is usually done in early November. A chairperson is also needed for our booth at the Mrs. Claus Bazaar on December 1st. This is an easy event, the primary challenge being the set-up and take-down of the booth. We also need a chairperson for the 2019 Raffle. There are several promotional and prize ideas being discussed, but a chairperson is needed to take control of the necessary paperwork and manage the ticket

Board Meeting of October 3 -


Meeting of the Board, Oct. 3, called to order at approx. 8:30 p,m, In attendance were President Linda C., Secretary David M., and Directors Dave White, Barb Ehlert, and Katelyn Mooney. Dave W. moved to maintain the current President, Secretary, and Treasurer positions, but to postpone the election for Vice President until the next regular Board meeting. David M. offered to serve as V.P. Pro-tem until that election. The motion was supported by Barb and passed.

The idea was put forth to offer something to the vendors and skilled tradesmen who were donating labor to the ICHS. Free rental of the House, acknowledgement on nameplates, free Business Buddy recognition were all mentioned as possibilities. No specific action was taken at this meeting.


